Please read this Privacy Notice. It relates to how PCERT Limited

("PCERT"/"we"/"us"/"our") holds and processes your information (data) and your rights.

About PCERT

PCERT is a private limited company owned by The PIPA Testing Scheme Limited (CRN: 11545157) ("PIPA"). Its main purpose is to undertake certification activities, assessing individual persons to perform a PIPA inspection using ISO17024. To help provide the correct governance structure to undertake certification activities in an impartial manner, PCERT has been set up as a separate company away from the PIPA testing scheme limited, and its governing board.

Our registered office is at 301 Tea Factory, Fleet Street, Liverpool, L1 4DQ.

PCERT does not own a website. It uses its parent company's website, www.pipa.org.uk ("website"), to provide information about the company and details about how to contact PCERT.

PCERT is a "data controller". This means that we are responsible for deciding how we hold and use data about you. We are required under data protection legislation to notify you of the information contained in this privacy notice. We have a duty to keep your data secure and maintain your confidentiality and we will do so.

PCERT's company structure

PCERT is operated by a Managing Director. The administration of PCERT is outsourced to its parent company, The PIPA Testing Scheme Limited. PCERT has set out to ensure the correct data protection policies are in place to ensure that your data is as equally protected if the administration was conducted in-house.

1) Applicants and Certified Persons

Information we collect:

The data we collect includes their name, personal address, company/business name, email address, contact telephone numbers, and postal address. It also includes any information provided to us as required by our scheme rules. This includes, but is not limited to, DBS confirmation checks, insurance details, and inspection report records.

As part of the application, you may be required to undergo an ID check against government approved documents. We use Stripe's verification software to complete these checks. This data is stored on Stripe's system, and is not downloaded to PCERT's system as part of the checks. More information can be found here:

We will also hold/process any other data that members provide to us voluntarily (whether via our website, by email, verbally, or in writing) or that we ask you.

How we will use your data:

In order to provide our services, we will use your data to:

- Administer your certification, including payments and future recertifications
- Deal with any queries raised by you
- Process any complaints or concerns raised against you
- Audit your work, or check compliance against the scheme rules
- Compile statistics and research
- Perform any necessary tasks as laid out within the scheme rules

- Assist the PIPA Testing Scheme Limited in their work, in line with a memorandum of understanding between the two legal entities (further details below).

In order to meet ISO 17024, and to properly carry out our function in public safety, we publish a register of certified persons to allow people to collaborate and confirm your certification with PCERT. We do so as part of a contractual arrangements to undergo certification with PCERT. You agree for us to use your information in such a way when undergoing certification or certifying.

How long we retain your data:

We retain all information and data relating to certification for a period of nine years. This enables PCERT to have sufficient information to handle a current certification period of three years, and a further two certification periods (resulting in a total of up to nine years). After nine years, the data will be deleted automatically by PCERT's software.

2) Visitors to our website

3) Complaints or Concerns

Part of the PCERT complaint process is handled by The PIPA Testing Scheme Limited when it relates to a certified person or applicant.

Information we collect:

If you submit a complaint to us, we will collect details about you in order for us to process the complaint. It will include your name, email address and phone number. It may also include details of your business, a correspondence address, and details of the concern raised. After submitting your complaint we will seek your consent to share this information with the member to whom the complaint is against, which will enable us to investigate the complaint in full.

How we will use your data:

We process complaints using consent as a lawful basis. You do not have to consent to PCERT or PIPA sharing your information in such a manner, but it would seriously restrict any complaint or action which we can take.

In the event the complaint or concern is of such a serious nature that we must inform an enforcing body (such as the Police or HSE), we will rely upon the lawful basis of a Vital Interest in order to process your data. When disclosing such information, we will only provide enough information as necessary to carry out the public protection task.

How long we retain your data:

Any details collected regarding a complaint or a concern may be retained for up to 10 years, unless there is an ongoing investigation which requires the information to be retained for longer. After this time period we may retain the complaint itself but remove any identifiable information.

Data sharing

The data collected by PCERT will be used in a manner which ensures it is kept secure and is not shared outside of the company without your express consent. When we refer to PCERT using your data, we mean: the office (which is a data processor and a separate contracted company), the managing director, PCERT's contracted service providers (who may be data processors), and any software PCERT uses in order to store and process your information. All of the above have written agreements in place which regulates their processing activities.

We work with a number of third parties in order to carry out some of our services and functions. The third parties act as an agent of PCERT and so have written agreements in place to protect and limit how your data is used. The basis they may use the data we share with them is limited solely to the intended purpose, for example; providing certification activities, or investigating a complaint.

We may also share data with our insurance provider or legal advisers where we deem it necessary to do so.

Your data will not otherwise be shared with any other third party without your consent.

Memorandum of Understanding (MoU)

PCERT holds an MoU with its parent company, the PIPA Testing Scheme Limited. The MoU is there to ensure the correct governance is in place around the use and storage of data, and to ensure PCERT can operate in an efficient manner. The MoU between PCERT and PIPA is a strict document, which ensures that no matter which company is handling your data, it is as secure as it was just PCERT.

Your rights

You have:

- right to be informed
- right of access
- right to rectification
- right to erasure/right to be forgotten
- right to restrict processing
- right to data portability
- right to object

We are obliged to ensure that the data we hold about you is correct. You have the right to ask for the data to be rectified if it is not correct and we will then take appropriate

action to do so.

You also have the right to restrict the processing of your data or to object to the processing of your data, as well as the right to ask that your data (or some of your data)

be erased.

Further, you have the right to seek confirmation of the fact that we are processing your

data, to ask what that data comprises, and also to ask for copies of your data we hold.
